

# BOARD OF DIRECTORS ELECTION INSTRUCTIONS

There are several options for voting for Directors in the April 23, 2026 election. First, make sure you qualify to vote! Class A members who have paid their calendar year CHOA dues in 2026 are eligible to cast one vote for each Director slot on the ballot. Vote only once. If more than one ballot per member household is received, no ballots will be counted.

1. **Mail your ballot** to CHOA Annual Meeting, PO Box 6461, Lakeland FL 33807-6461. Mailed ballots must be received at the PO Box before noon on April 23, 2026.
2. **Email your ballot** to [christinahoa.secretary@gmail.com](mailto:christinahoa.secretary@gmail.com) or **text your ballot** to 863-268-5881. The ballot **must be a picture** of the completed ballot or proxy form and be received before 7:00 pm by April 23, 2026. The email or text must include your name and address for verification.
3. **Hand deliver your ballot** to the CHOA Secretary at 6717 Woodside Ct. before 7:00 pm by April 23, 2026.
4. **Attend in person** the virtual Annual Meeting to cast your vote. Join via the link at [www.christinahoa.org](http://www.christinahoa.org).
5. **Vote by proxy.** Complete the proxy form below to have your designated proxy vote on your behalf.

Remember, duplicate ballots, or ballots received after the deadlines stated above, will not be counted. A plurality of votes cast by Class A members for each Director position will elect the Director. No quorum of the membership is needed.

## Proxy Authorization Form (if desired)

I designate the following person to be our proxy, and they are entitled to vote on my behalf at the Christina Homeowner's Association Inc. 2026 Annual meeting. This proxy form may be mailed in advance of the meeting or presented at the meeting.

By this designation of proxy, the proxy may attend and represent the homeowner with the full power to vote and act for the homeowner in the same manner, to the extent and with the same effect as if the homeowner were personally present. This designation revokes any prior designation of proxy that the homeowner may have given previously with respect to the homeowner's membership interest in the Christina Homeowner's Association. This designation of proxy shall be effective for the annual meeting to be held on April 23, 2026 via virtual meeting, and at all adjournments of such meeting. The proxy shall have full power, as the member's substitute, to represent the member and vote on all issues and motions that are properly presented at the meeting for which this designation of proxy is effective. The proxy shall have the authority to vote entirely at the discretion of the proxy.
